If successful, we could continue with this into the future. Attendance at games will follow guidelines (e.g., if restaurants are at 25% occupancy, games will be.) The games will be run through the streaming company's website, not Scotts Valley. Can also watch games later.

Louie is spreading the word to coaches and parents that registration is online and players can do that now. We have all the coaches we need at this point though might still need track and swimming coaches.
